In the tragic event of a family member, spouse, student, or a member of the Mount Union community passing away, human resources should be contacted. Human Resources will then use the following procedures to contact the appropriate people and provide counsel and accommodations through this difficult time.

- 1. Faculty or Staff Member's Parent, Spouse, Child or Domestic Partner's Death
  - a. Notify the Human Resources Department.
  - b. The Human Resource Department will send flowers. The card will read: "With prayers and sympathy, The University of Mount Union".
  - c. If permission is granted by the Faculty or Staff member, The Human Resource Department will communicate to the campus community detailing the arrangements. No biographical details will be given. The communication currently reads as follows: We extend our deepest sympathy to <u>Faculty / Staff's name, Title, & Department of University</u>, whose <u>parent</u>, <u>spouse</u>, <u>child</u>, <u>& name of deceased</u> passed away on <u>date</u>. Calling hours will be <u>time</u>, <u>date</u>, <u>location</u>. The funeral will be <u>(time, date and location)</u>. Please keep the <u>name</u> family in your thoughts during this difficult time.
  - d. The Vice President will have discretion on whether flowers should be sent in the death of anyone other than a parent, spouse, child or domestic partner.
- 2. Faculty or Staff Member's Death:
  - a. The appropriate VP notifies President's Council.
  - b. President's Council will decide whom, if anyone, should attend the calling hours or the funeral.
  - c. VP of Business Affairs will notify the Human Resource Department.

- d. The Human Resource Department will send flowers following same steps as in #1a, b and c above.
- e. The appropriate VP will coordinate with the Marketing Department a biographical release to the campus community, if applicable.
- 3. Student's Parent or Sibling Death:
  - a. Notify Student Affairs.
  - b. Student Affairs to notify appropriate faculty and administrative personnel
  - c. Student Affairs will decide whom, if anyone, should attend calling hours or funeral.
  - d. Student Affairs has discretion on whether to send flowers.
- 4. Death of Student
  - a. Notify Student Affairs.
  - b. If necessary, Student Affairs will notify family (in conjunction with chaplain or faculty who may have had a relationship with student, if appropriate).
  - c. President's Council will determine if anyone other than Student Affairs Staff should attend the calling hours or funeral.
  - d. Flowers will be sent.
  - e. Student Affairs will notify the campus community as appropriate.
- 5. Death of Alumni or Friends
  - a. Notification given to Advancement (can come in a variety of forms).
  - b. VP of Advancement consults with Advancement Staff about appropriate response
  - c. Advancement has discretion on whether to send flowers.

Office of Business Affairs	Will help to coordinate who needs to be contacted		
Advancement	Will send flowers to the family or where deemed appropriate
